Approval of the April, 2012 minutes:

Laura Mayer moved to approve minutes, Rich Kinkade seconded. Motion passed.

Unfinished Business:

Motorcycle Safety & Awareness Rally-Everything ready to go. Radio station attending; sound system at Capitol; vendors at IDOT. Pauli Ward and Julie Bacon to count bikes. Be ready to set up at 7⁴⁵ am. Need step to hang banner and flags. Jim Cone and Carleen Grant will set up barricades.

2013 Rally-Discussion of changing starting time to 10⁰⁰ am. People use the Rally as a get-together to visit and network. **Decided to leave start time at 8⁰⁰ am.**

Pay Pal-Ernie Steele (webmaster) has had difficulty connecting through our server. Our server is very limited. We need to consider another server with more options. Ernie Steele will put together a package deal with prices for a new server and present at June EBoard meeting, no later than September. Bob Dodson suggested a committee to help put together the package presentation. **Rich Kinkade will work with Ernie Steele on obtaining prices for a new server that will allow Pay Pal to be connected as well as link the Chapter websites.**

Scott Gerke moved to close unfinished business, Bob Dodson seconded. Motion passed.

New Business:

1. Posters) Legislation posters that list bills ABATE has been instrumental in passing that have been used with the Bike Raffle. There have been many conversations about how to obtain the posters but nothing has been done yet. Discussion: Proposed for Products to sell. Bob Dodson reported his print shop has fast turnaround time, \$75 per laminated set, with 2 ½ sets-20% discount, easel purchased at Wal-Mart. Shipping-pick up at BOD meeting, ordered from Products. Office Max could print if file was available. The list of bills will be added to during the year so vinyls can be added to fill remaining space on this design. Put on website? Design is a .pdf file and already on website. **Need to tell BOD members that the Legislative Poster is available on the website; can be downloaded to be printed.**
2. Product Trailer) Needs stabilizer jacks, insulation, shelves, wiring, lighting, air conditioner, generator, extra bracing for roof top air conditioner. Discussion: structurally sound?; needs rooftop bracing for roof top air conditioner makes too heavy; if sent back to factory cost would be over \$4400; four (4) state events taken to, only one (1) without electricity; trade-in?; time delay paying for trailer caused cost to go up; weight of trailer is big issue; fix trailer but no graphics. **Pauli Ward moved to have Bob Dodson have the Products trailer fixed with what it needs except for the roof top air conditioner, the additional bracing and the large generator; Rich Kinkade seconded. Motion passed. 3. Swap Meet 2013) Move to 3rd Sunday of February, 2013.
