### **Unfinished Business:**

- 1) Website-Purchase of server is 25% of cost; administration is 75%. Server cost would be about \$1000, software about \$3000, special phone lines about \$1200 and installed in a climate controlled environment. Cost prohibitive and need a full time administrator. Pay Pal is now working on website. **Need to pull this item off agenda because it has been resolved.** Chapter website guidelines are out of date per webmaster, Ernie Steele. **Rich Kinkade will take care of updating website guidelines.**

### **New Business:**

- 1) Inventory) A few small items have been purchased this year.
- 2) Christmas Party) Christmas Party will be following the December BOD meeting at Crows Mill. American Income Life will be donating for the refreshments.

- 3) Emails) Got out of control again, for the second time from the same region, NE Region. Mike Myers visited the region the first time and the matter was resolved to the satisfaction and cooperation of all. This time there was a miscommunication regarding the funding of the Chicago Expo. The EBoard discussed the profitability of ABATE of IL funding this event for recommendation of the 2013 budget to the BOD. The discussion was that if the NE Region wanted to fund this event but they were not required. There were emails exchanged with incorrect information that created hard feelings and had nothing to do with motorcycle rights. Just a few chapters should not be able to dictate what the rest of the chapters do. **It is extremely important to talk and cooperate with each other.
